



Update: Notice of temporary traffic lights on A53, Whitmore

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty and its appointed subcontractors are working on behalf of HS2 Ltd to carry out early environmental works between Lichfield and Crewe.

What we are doing

As part of our early environmental works, we are establishing critical environmental and species relocation sites creating new habitats for local wildlife before any main construction work starts.

We have been creating ecological mitigation ponds surrounded by grassland habitat creation on land to the south of the A53 at Coney Greave Farm. We will use the ponds to relocate any protected species, such as Great Crested Newts.

We are nearing the completion of work on this worksite, and now need to remove the temporary trackway installed in order to complete the works.

We will need to install temporary two-way traffic lights on the A53 at Whitmore, to manage the safe movement of the vehicles needed to remove the temporary trackway from site.

When the work take place?

We will put the traffic lights in place from **Monday 19 June to Friday 23 June 2023**, from 9am to 5pm.

What we will do

Carry out the work in compliance with the Code of Construction Practice.

Inform you in advance of any changes to the dates and working times shown .

What to expect

Some low-level noise.

Movement of vehicles and plant on/off the A53.

Temporary traffic lights on the A53 between Common Lane and Bent Lane.

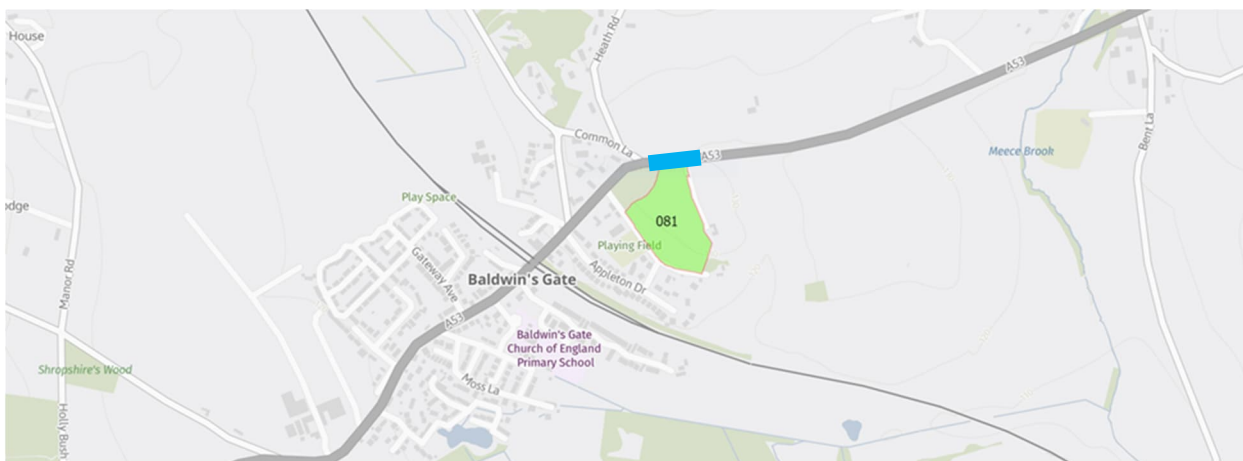

What to expect

The equipment we use may generate some low-level noise, we will be switching off engines when not in use and working during the day to minimise disruption to local residents. We will use the current farm access to bring the machinery onto the land.

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
