Notice of ground investigations on Loudoun Road

High Speed Two (HS2) is the new high speed railway for Britain.

Ground investigations on Loudoun Road

From 10 July 2023 to 18 July 2023 (Phase one), and 19 July 2023 to 28 July 2023 (Phase two) we will be carrying out a series of ground investigations on **Loudoun Road**.

The ground investigations will consist of digging a temporary trench to confirm the location of utilities under the surface of the road. The investigations will help us to understand and aid the design of the new railway and the best ways to protect or divert any utilities during construction. Your utility services will not be affected during these works.

The ground investigations will take place between 8am to 6pm Monday to Friday and 8am to 1pm Saturdays, if required. We will use noise reducing barriers where possible to help minimise any noise disruption to the local community, working as efficiently as possible whilst keeping our work areas safe and tidy.

How will this affect you

To ensure the safety of the public and our staff, temporary changes will be in place on Loudoun Road during both phases shown on the following page. These include:

- Closure of the bridge on Loudoun Road next to South Hampstead Station.
- Traffic diversion route via Alexandra Road and Hillgrove Road
- Suspended parking on the bridge
- Pedestrian access will be maintained with a signed route

Clearly signed diversion routes for vehicles and pedestrians will be in place.

Your utility services will not be affected during this time.

Temporary closure of bridge on Loudoun Road and diversion

Suspended parking on Loudoun Road

Pedestrian diversion route in place on Loudoun Road

Continue to monitor our working methods to reduce disruption

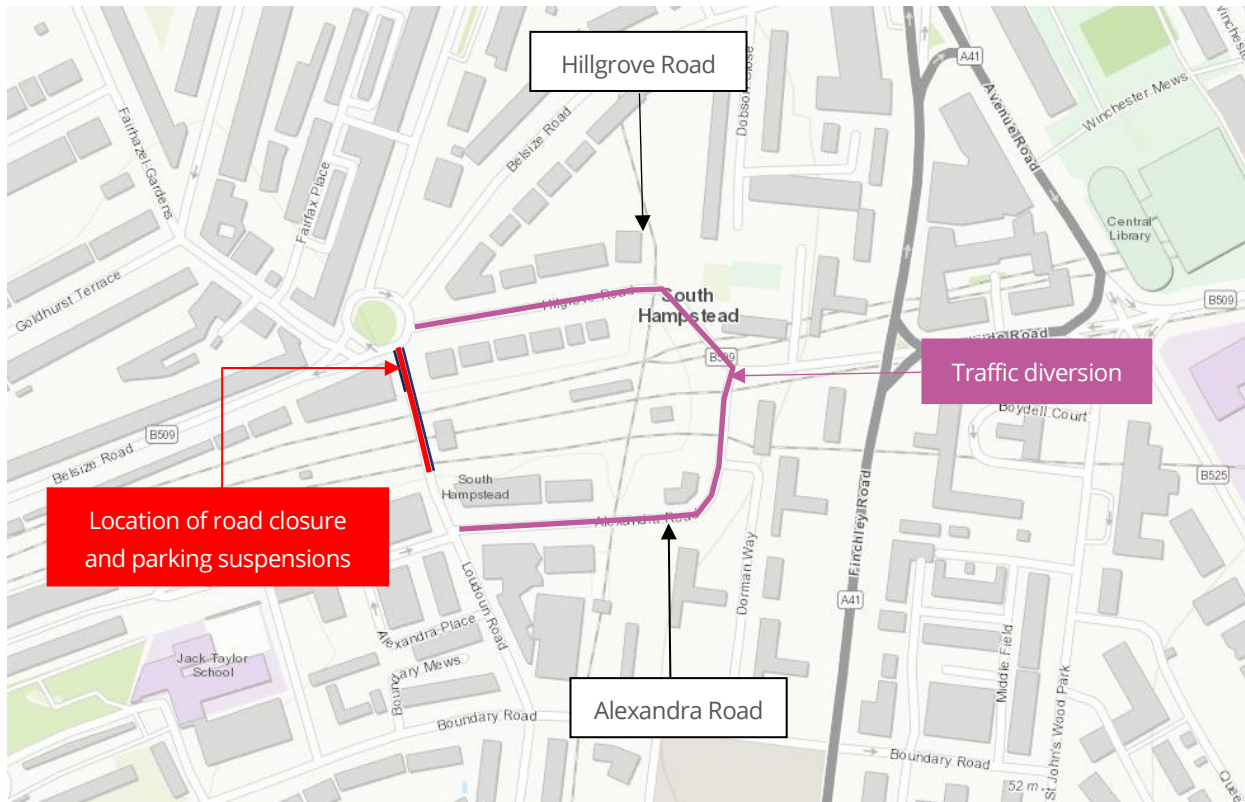
