# Update: road closure extended on Park Royal Road

High Speed Two (HS2) is the new high speed railway for Britain.

### Road closure extended on Park Royal Road

We recently wrote you about a temporary road closure planned on Park Royal Road to carry out over pumping works on the main sewer network.

The road closure was planned to be in place from 6pm on Friday 23 June until 11:59pm on Sunday 25 June 2023. Due to a change in the construction programme, the road closure will now be extended until 5am on Monday 26 June 2023.
