High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.



### Hoarding change at Cobourg Street – North

Further to direction provided by the Government, multi-utilities works previously anticipated on Cobourg Street in 2023 have been paused. This means an opportunity now exists to move the hoarding line at Cobourg Street – north. This will enable vehicular access and on-street parking to be reinstated.

**From w/c 12<sup>th</sup> June to late June 2023, we will be resurfacing Cobourg Street – north within the HS2 work site. We will then move the existing hoarding line eastwards to widen the road. We are anticipating Cobourg Street – north to reopen in July 2023 (subject to change).**

As we move the hoarding, there will be no through access for pedestrians. Please access Euston Station via Drummond Street. Residents on Cobourg Street – north will be able to access/ exit their properties. We apologise for any inconvenience caused whilst the new hoarding is being installed.



### Duration of works

w/c 12<sup>th</sup> June to July 2023

### Working hours

- 8am to 6pm weekdays (excluding bank holidays)
- On occasions it may be necessary to work 8am to 6pm weekends
- We will start-up and close-down activities up to one hour before and after normal working hours

### What to expect

- Surface breakout, installation of new road surface and road painting
- Use of floor saw, excavator, hand tools, compressor, generator and dumper
- Traffic management
- Pedestrian access will be maintained for residents on Cobourg Street - north
- Noise and vibration

### What we will do

- Aim to reduce noise and vibration as reasonably practicable
  - Keep all sites safe and secure
