What are we doing?

EKFB are building a permanent road for maintenance access to the railway along the A425 Leamington Road in Southam. During this closure period we will be joining the new access road to the highway and carrying out some localised vegetation clearance.

To carry out these works, the A425 will have traffic management in the form of a single lane closure with two-way traffic lights for approximately three weeks in July.

During this time there will be occasions when we will need to work across the road, traffic may be held at the lights for no more than 15 minutes to ensure a safe working area.

When will these works take place?

A section of the A425 Leamington Road will have traffic management, 8am to 6pm, from Monday 10 July to Friday 28 July 2023.

These dates may be subject to change due to circumstances outside of our control, such as poor weather.

Duration of works

The A425 will have traffic management from Monday 10 July to Friday 28 July 2023.

Normal working hours:

Monday to Friday

8am – 6pm

Our contractors may be on site for one hour's start-up and shutdown either side of these times.

What to expect

Traffic lights on a section of the A425 for three weeks.

Access will be maintained for residents and emergency services.

What we will do

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.


