
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be carrying out topsoil stripping in areas close to Gilson Road.

Traffic management

In order to complete this work safely, we will install three-way traffic lights along a short section of Gilson Road and within our existing site access, from Monday 3 July until Friday 14 July. The location of the traffic management is shown in the map below. The traffic lights will be in place from 9.30am until 3.30pm, Monday to Friday.
