High Speed Two (HS2) is the new high speed railway for Britain.

Lane closure

From 10 to 12 July 2023, * we will need to close a lane on Adelaide Road, as shown in red on the map below.

We need the lane closure to hold machinery while we carry out roof repairs on the welfare buildings and remove concrete from the site.

An area in front on Constable House, as indicated in orange on the map below, will be used as a lay-by to allow refuse collection services to continue.

We will put three-way temporary traffic lights in place, as indicated on the map below.

Bus-stop R, opposite the site, on Adelaide Road, will be suspended. The closest alternative stop is outside Chalk Farm station.
