High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

The new railway will follow the path of an old, decommissioned branch line which is now known as the Kenilworth Greenway. The existing humpback bridge on Waste Lane is too small to accommodate the new railway and will need to be replaced. Before we start construction of the new bridge, we will need to close Waste Lane to carry out some early preparation work. The road will close at 9:30am until 3:30pm from 10 July until 14 July 2023. Access for residents and pedestrians will be maintained.
