High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

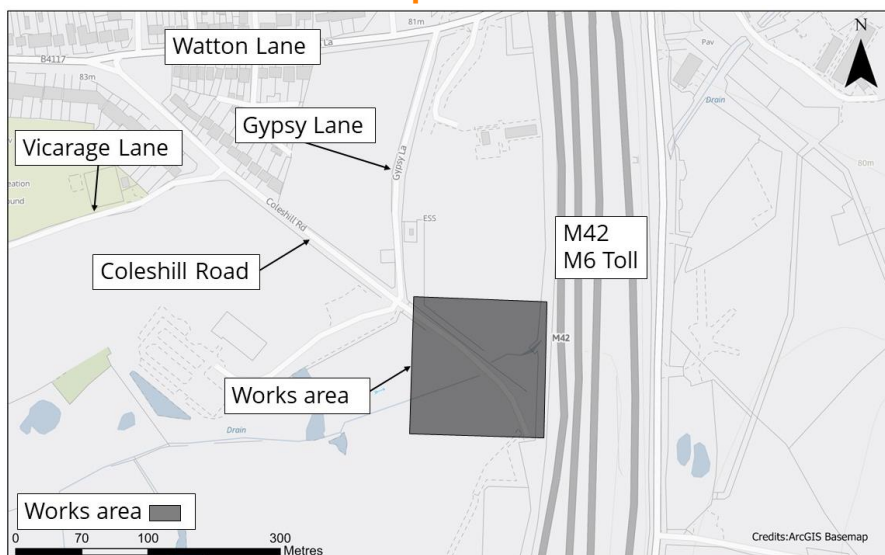
The work we will be doing

To continue our works for Water Orton Viaducts, that will carry the HS2 railway over the M42 M6 Toll, we will complete a concrete pour for pile caps. A pile cap is a concrete mat that is laid above the piles to provide a stable foundation for us to build the structure.

When the work will take place

Due to the hot weather expected and to reduce disruption to the local road network, the pour will take place overnight from Friday 7 July at 8.00pm until Saturday 8 July, with an estimated completion time of 10.00am. However, due to the nature of the works, this may continue until 6.00pm on Saturday with deliveries of concrete taking place throughout the day.
