
Notice of works at Curzon Street Station site

High Speed Two (HS2) is the new high speed railway for Britain. Mace and Dragados, known as MDJV will be carrying out early works on the Curzon Station site. Both Mace and Dragados are well regarded in the construction industry.

Graffiti removal - Curzon Street Station hoardings

MDJV will be starting preliminary works in preparation for the construction of HS2's Curzon Street Station and the railway. These works will include the removal of graffiti along the current site boundary hoarding, which may narrow existing walkways.
