



Updated notice of temporary closure of Park Lane, Huddlesford

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We will be working on the new diverted Park Lane to complete the verges and ensure these are safe for road users. To complete these works safely we will require temporary daytime closures of Park Lane.

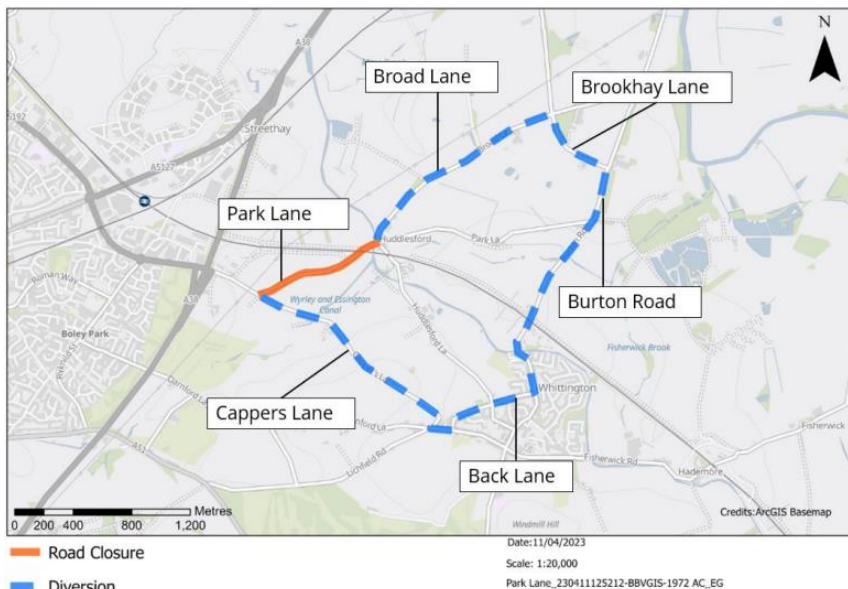
When the work will take place

To enable us to complete additional road marking and surfacing works we have extended the daytime closures by two days.

We will install the temporary road closure between 3 July to 7 July 2023. The closure will be in place from 9.30am to 3.30pm each day.
