High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

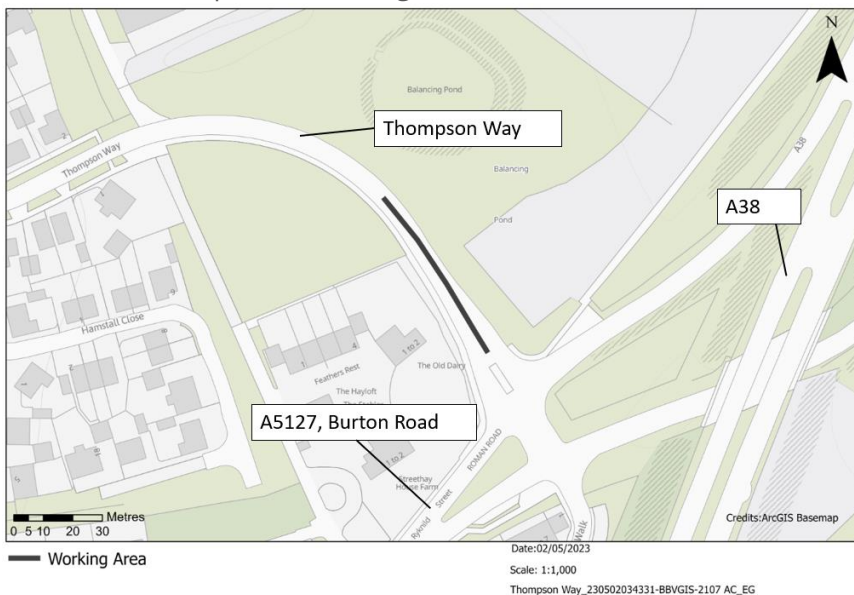
We will be undertaking works along Thompson Way to construct a new access to our worksite. These works include resurfacing a section of the highway, replacing the kerb line with dropped kerbs and installing white lines and signage.

When the work will take place

We will undertake these works from 3 July to 6 July 2023. To carry out our works safely we will install temporary traffic management. Our working hours will be from 8am to 6pm each day.
