High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

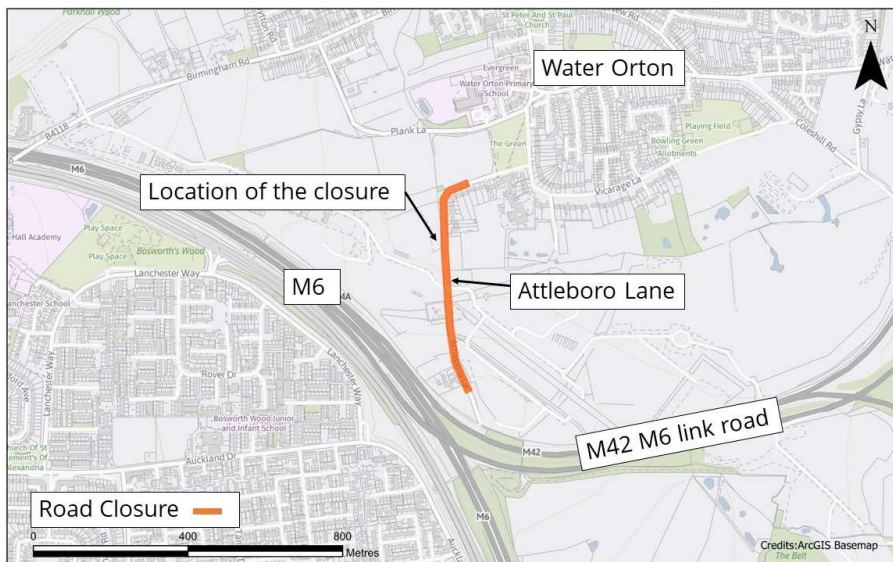
The work we will be doing

In order to prepare for our continued construction in the area, BBV will complete trial hole works on Attleboro Lane.

Updated: Due to unforeseen circumstances, the works will not take place on Monday 17 July and will now take place on Tuesday 18 July and Wednesday 19 July.

Traffic management

To complete these works safely, we will install a temporary road closure along Attleboro Lane from 9.30am until 3.30pm each day. The road closure will be marshalled, so access for residents and pedestrians will still be maintained throughout.
