High Speed Two (HS2) is the new high speed railway for Britain.

Utility works on Victoria Road

From **18 to 20 August 2023** we will be carrying out works to protect the utility services below Victoria Road and the surrounding areas ahead of future tunnelling works.

The works will take place between **8am to 6pm Monday to Friday** and **8am to 1pm Saturdays**, if required. We will use noise reducing barriers where possible to help minimise any noise disruption to the local community, working as efficiently as possible whilst keeping our work areas safe and tidy.

Your utility services will not be affected during these works.

What to expect

To ensure the safety of the public and our staff, temporary changes will be in place on Victoria Road. This will include temporary traffic lights and pedestrian crossing, a narrowed lane and bus stop suspension.
