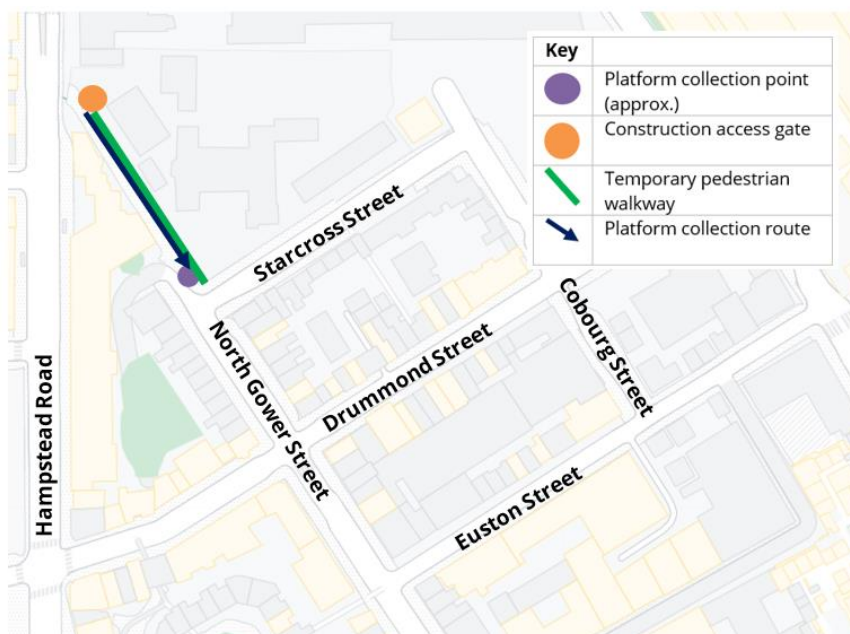

Removal of a Mobile Elevating Work Platform on North Gower Street on Saturday 15th July 2023

Works continue to progress at the former Maria Fidelis school site to deliver staff office facilities and the Construction Skills Centre. As part of this work, we now need to remove a mobile elevating work platform on Saturday 15th July for approximately 2-3 hours. The platform will be removed from site via a construction access gate located on North Gower Street – see below plan. Pedestrian access will be maintained via a temporary walkway. Traffic marshals will also be in place to hold back pedestrians whilst the platform is removed from the gate for collection. Please be reassured that access/ egress from George Mews properties will be maintained.



Duration of works

Morning of Saturday 15th July 2023 for approximately 2-3 hours

Working hours

- Saturday 8am to 6pm
- We will start-up and close-down activities up to one hour before and after normal working hours

What to expect

- Removal of a Mobile Elevating Work Platform from site via gate at North Gower Street
- Traffic management
- Temporary pedestrian walkway
- Traffic marshals in place

What we will do

- Aim to reduce noise and vibration as reasonably practicable
 - Keep all sites safe and secure
