

# Notice of Wendover bypass lane and layby closures

## What are we doing?

We will be implementing lane closures on the A413 Wendover bypass from Monday 14 August to Friday 18 August to finalise the installation of a power connection to our site off the bypass.

To complete these works safely we will be using traffic lights on a section of the bypass along with temporarily closing the layby on the Eastern side of the road as shown in the map below.

## Why are you doing these works?

To reduce the number of deliveries to our sites and to maintain a readily available source of concrete for our works, we have set up our own concrete batching plant at our Wendover Green Tunnel site.

We have been using generators since the plant became operational last year, but for us to gain a more sustainable power source with less emission production, we will be connecting the plant to the power grid.

We began these works in February and will use this closure for the final completion stage for this connection. The works will involve excavating part of the Wendover bypass to insert a high voltage cable across the road.

## When will these works take place?

- Monday 14 to Friday 18 August, this lane closure will be in place 24 hours a day.

### Duration of works

Monday 14 to Friday 18 August.

The closure will be in place 24 hours a day due to presence of open excavation.

Provide fully signposted diversion.

Manage any noise or traffic impacts.

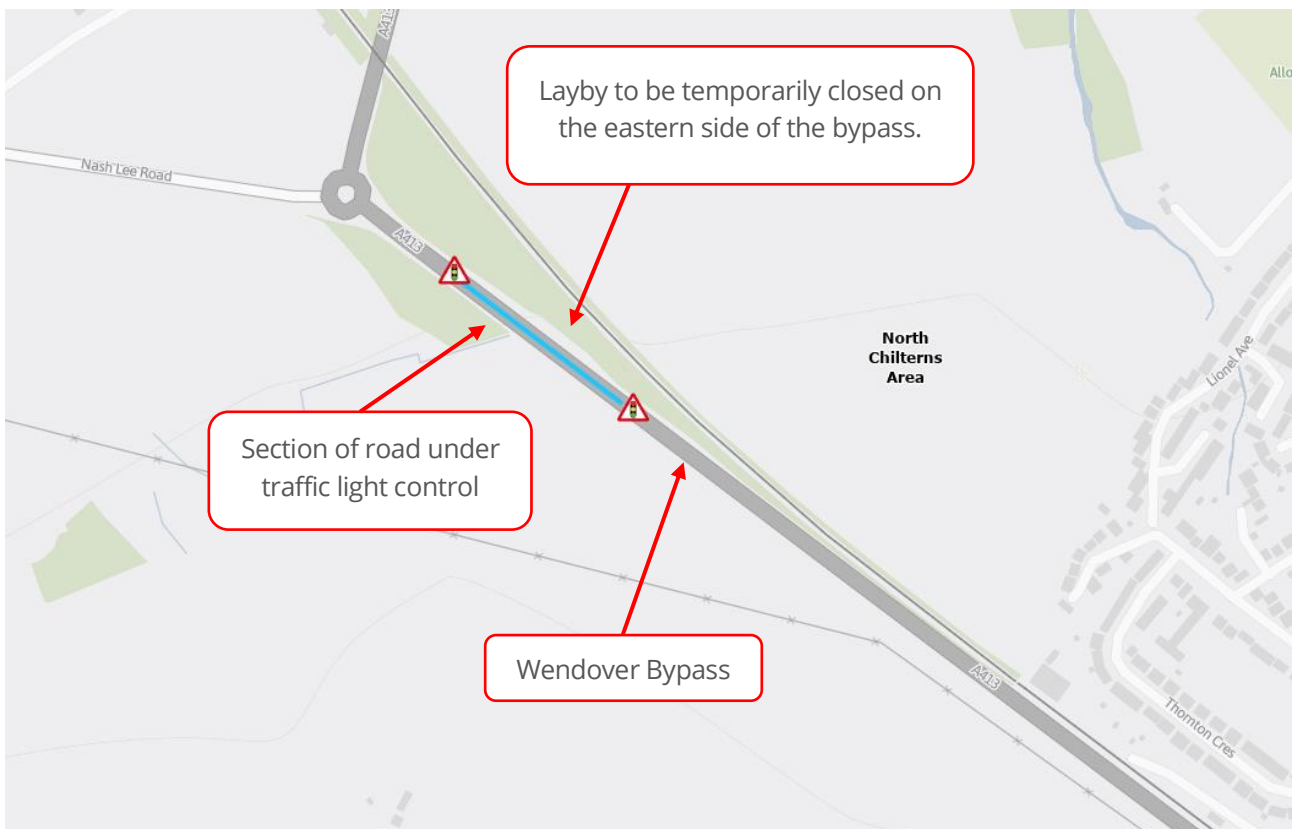
## How will this affect me?

Access to the bypass will be maintained for road users. We will introduce temporary traffic lights to manage the lane closure which will be in place 24 hours a day for the duration of the works.

The layby will also temporarily be closed while we are working in this location but will re-open as soon as we have completed our works.
