#### What are we doing?

From early autumn 2023 we will be opening a new temporary road, known as the 'Greatworth T'. This new temporary road will keep traffic flowing to villages north of Greatworth, while we build the Greatworth Green Tunnel.

To prepare for this we will be closing Sulgrave Road, near Greatworth from late July. We will also be working on Welsh Lane, requiring periods of temporary traffic lights. This is to build a junction to connect the new temporary road with Welsh Lane.

The Greatworth T will be open two phases. The first will create a diagonal link between Magpie Farm, near Sulgrave, and Welsh Lane near Helmdon Road in Greatworth. With this first phase open, the main section of Sulgrave Road will close for approximately 18-24 months.

The second phase of the Greatworth T will open when part of the tunnel is completed. This will create an additional link road from Welsh Lane, allowing the tunnel work to continue towards Greatworth.

A map showing the Greatworth T layout is included in overleaf.

#### When will these works take place?

- A section of Sulgrave Road will be closed from 31 July to 31 August 2023, 24-hours a day. A diversion will be in place.
- There will be traffic lights on B4525, Welsh Lane from 14 to 23 August 2023.
- From September 2023 phase one if the Greatworth T will be open. The exact opening date is to be confirmed and will be subject to the completion of the Highways safety check for new roads.
- Once the Greatworth T is open, the main section of Sulgrave Road will be closed for approximately 18-24 months while we build the tunnel.

#### **Duration of works**

Sulgrave Road will be closed 24-hours a day from Monday 31 July to for approximately one month.

From September, once open the Greatworth T is in operation, it will provide a long term diversion for access along Sulgrave Road.

B4525 Welsh Lane will have traffic management from 14 to 23 August 2023.

The Sulgrave Road will be closed 24 hours a day.

#### What to expect

Full road closure of Sulgrave Road for approximately one month to carry out tie works for a new temporary diversion.

Traffic lights on Welsh Lane.

#### What we will do

Respond promptly to any complaints and take appropriate action. Take care to respect the community.

#### Where will the works take place?

The map below shows Sulgrave Road, which will be closed 24 hours a day from Monday 31 July 2023 for approximately one month, with the below the local diversion in place.

As well as the location of traffic lights on the B4525, Welsh Lane from 14 August to 23 August 2023.



**Greatworth T - Phase one**: From September 2023 the first section of the Greatworth temporary road will be open providing an alternative route for traffic while we build the first section of the Greatworth Green Tunnel.



**Greatworth T - Phase Two**: In 2024 the final part of the Greatworth temporary road will open over the completed section of the Greatworth Green Tunnel. We will then build the southern sections of the tunnel, while traffic uses the completed temporary road layout.
