High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We would like to take this opportunity to notify communities of some abnormal load movements over the summer months.

We will be transporting large sections of Dorothy, the tunnel boring machine (TBM), to the new tunnel site near Birmingham. The movements will be carried out from 15 July until 30 September 2023, 9pm to 2am.

The abnormal loads will be moved with the support of a police escort under a series of rolling road closures in the early hours of the morning.

We thank you for your co-operation and apologise in advance for any inconvenience.

What defines an Abnormal Load movement?

An abnormal load is a vehicle that has a weight over 44,000kg, a width of more than 2.9 metres or a rigid length of over 18.65 metres.

How do we get approval for abnormal load movements?

All abnormal load movements are booked through the Electronic Service Delivery for Abnormal Loads (ESDAL) system which is operated by Highways England. As part of the process the appropriate Police and Local Highways Authorities are automatically notified and will consent the route to site.

The movements will be carried out from 15 July to 30 September 2023, 9pm to 2am

Abnormal loads will be from the compound towards the M40 and on to Birmingham

These will be overnight to reduce the impact on communities
