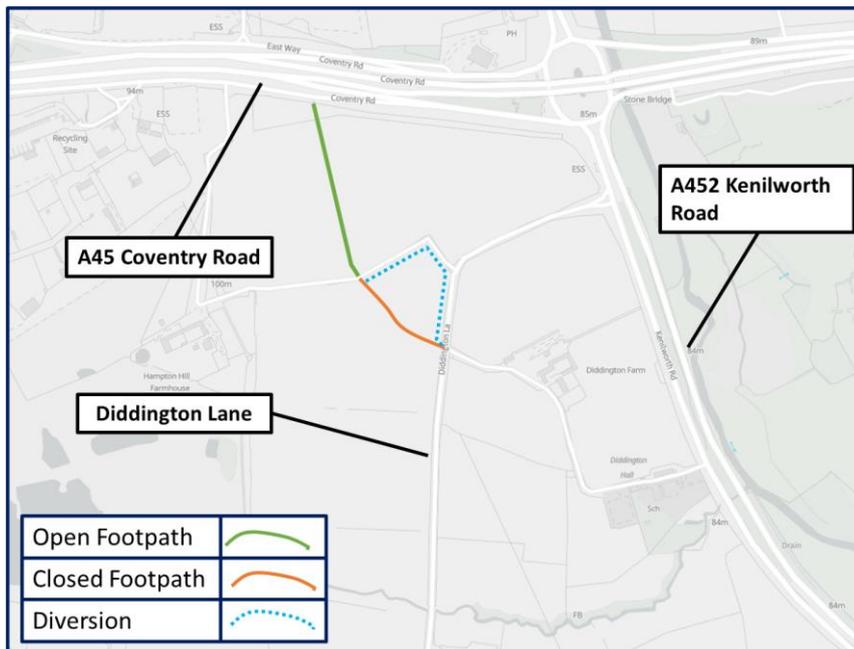

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

The work we will be doing.

The new railway will approach the A45 in a cutting. Before we begin the earthworks to form the cutting there is an electricity cable that that will need to be safely diverted to avoid our works interrupting the supply. In order to do this a footpath leading from the A45 to Diddington Lane will need to be slightly diverted around our worksite. Please see the Map below
