
The work we will be doing

To continue our works for Water Orton Viaducts, that will carry the HS2 railway over the M42 M6 Toll, we will complete another concrete pour for pile caps at our compound on Watton Lane. (Location shown on the map below). A pile cap is a concrete mat that is laid above the piles to provide a stable foundation for us to build the structure.

When the work will take place

These works were due to be completed on Friday 11 August. However, due to reprogramming of the works, this will now take place on Friday 18 August from 7.00pm until an estimated time of 6.00pm on Saturday 19 August. As part of this work, we will deliver concrete to our site overnight from 7.00pm on Friday evening until Saturday morning at 8.00am. Our deliveries will enter site via Watton Lane for this time period. Then from 8.00am on Saturday morning all deliveries will enter our site via the M42 M6 link road access. Throughout the duration of the works, all deliveries will exit site via the M42 M6 link road access.
