High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area


UPDATE

We previously contacted you to advise that these night closures would finish on 26 August. Due to additional work required we will need to extend these works to 8 September. The closure will not be in place over the August bank holiday weekend.

The work we will be doing.

BBV have been significantly reconfiguring the junction of the A446 Stonebridge Road and A452 Chester Road near Birmingham Business Park to facilitate the construction of a bridge that will take the new railway over the M42. As this work enters its final phase, we will need to close the northbound carriageway overnight to install permanent signage, road illumination and traffic signals along with other minor civil engineering works on the new junction. This work will take place from 8pm at night until 6am the following morning from 14 August until 8 September. A fully signed diversion will be in place.
