Notice of temporary traffic lights on Gilson Road, Coleshill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be carrying out work to create a site access along Gilson Road.

Traffic management

In order to complete this work safely, we will install two-way traffic lights along a short section of Gilson Road from Monday 31 July until Friday 11 August. The location of the traffic management is shown in the map below. The traffic lights will be in place 24 hours a day throughout construction and will be manually controlled throughout peak hours to reduce impact to traffic. Our working hours are 8.00am until 6.00pm Monday to Friday and 8.00am until 1.00pm on Saturdays.
