# **Notice of traffic** management on B4114 **Birmingham Road, Coleshill**


High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

#### The work we will be completing

We are continuing to prepare for works to construct the Coleshill Viaducts that will carry the HS2 railway over the existing B4114 Birmingham Road. We previously sent out a notification outlining phase one of traffic management that took place from Monday 26 June until Saturday 1 July, to begin works to widen our existing site access. Following this, we will begin phase two of this work from Monday 14 August until Saturday 19 August.

#### **Traffic management**

To complete this work safely, we will install four-way traffic lights along B4114 Birmingham Road. This will include the roundabout section. The traffic lights will be in place from Monday 14 August until Saturday 19 August. The traffic management for this work will be from 9.30am until 3.30pm each day.



#### **Duration of works**

Four-way traffic lights in place along B4114 Birmingham Road from Monday 14 August until Saturday 19 August
