

Update: Out of hours deliveries to Adelaide Road Site

High Speed Two (HS2) is the new high speed railway for Britain.

Crane and piling rig deliveries to site

On **Friday 28 July 2023** and **Monday 31 July** we are expecting two large deliveries of a crane and piling rig to the Adelaide Road site. Both deliveries are scheduled to arrive before 8am, outside of our core working hours. This is to ensure a reduced traffic flow on designated routes.

The crane and piling rig will be installed on a working platform 10 metres below road level and will be used for piling works. The top of the crane and rig will be visible to residents for the duration of the piling works.

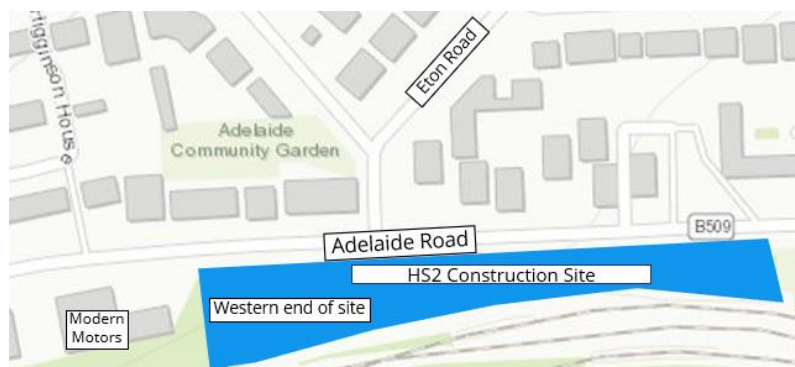
The piling works are scheduled to start on 31 July and continue until late October 2023.

How will this affect you?

You may hear reversing signals and engine noise during deliveries.

We will be monitoring the noise levels throughout these works to ensure minimal disruption to residents.
