









# **Update on utility works on Greenford Road, Ealing**

High Speed Two (HS2) is the new high speed railway for Britain.

### What we are doing

We wrote to you in June to let you know that we would be installing a protective lining in the sewer system on Greenford Road. The works were due for completion on 31 July 2023.

We wanted to let you know that these works will now be completed later than expected. We will now finish these works on **4 August 2023** at 6pm.

The junctions of Bennetts Avenue and Uneeda Drive onto either side of Greenford Road will be closed. Clearly signposted diversion routes will be in place.

Traffic management with a lane closure and additional traffic lights will be in place 24 hours a day for the duration of these works.

### How these works might affect you

We will use noise reducing barriers to minimise disruption.

We would like to apologise in advance for the disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way.

We will ensure that disruption is kept to a minimum.
