

Update: extension to utility works on Adelaide Road

High Speed Two (HS2) is the new high speed railway for Britain.

UK Power Networks work

UK Power Networks are currently installing electricity cables on Adelaide Road.

A notification was sent out recently, to explain the works, and that the work on the pavement outside 76 Adelaide Road would be completed on 21 July.

These works have overrun. The works are now scheduled to be completed on Tuesday 25 July.

The current traffic management will remain in place until Tuesday 21 July.

There will be a partial lane closure and pedestrian diversion outside 76 Adelaide Road.

Temporary traffic lights will be in use.
