High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

Vodafone utility diversion works on Eversholt Street, Lidlington Place and Cranleigh Street

We wrote to you in June 2023 regarding utility diversion works (Reference number: HS2-MW-MD-Ph1-Eu- St-S3-Prog-works-01-13/06/2023).

What are we doing?

We are undertaking Vodafone utility diversion works to divert Vodafone telecoms cables, enabling the construction of the future HS2 Euston Station. From **24 July until late August 2023** we will begin the next phase of these works on Eversholt Street, Lidlington Place and Cranleigh Street. The construction will consist of breaking out sections of the existing highway, installing ducting and reinstating the highway. To minimise impact on local traffic we will undertake the works in phases. During phase 3 we will need to close Cranleigh Street and Eversholt Street Southbound Carriageway **for one week (mid-August 2023)** to enable the diversion of the utilities. Pedestrian crossings will remain in use throughout these works.



We recognise that construction work can be disruptive to those living and working nearby. The nature of our work often means some disturbance is unavoidable but assured that every effort is made to minimise any unnecessary noise. Please note that changes to the programme may occur and if these changes are likely to cause any disturbance, we will write to you again.

Duration of works

- From 24 July until Late August 2023

Working hours

- 8am to 6pm weekdays
- Start-up and close-down activities up to one hour before and up to one hour after working hours above
- Works may take place at other times

What to expect

- Traffic delays
- Narrow lanes
- Pedestrian access maintained
- N5 and N20 buses will be diverted. To find alternative bus routes and stops please visit: www.tfl.gov.uk/maps/buses

What we will do

- We will take measures to reduce noise and dust
- Use of acoustic blankets when breaking out the road
- We will closely monitor all noise, vibration, and dust levels to ensure we do not exceed our agreed limits.
