What are we doing?

In June the temporary realignment of Nash Lee Road was opened for public use. In the medium-term, the introduction of this road will result in a significant reduction in the impact to road users during the construction of the HS2 project in this area.

As part of the final works on this new road layout we need to install a road closure in order to introduce some further safety measures in the location of the roundabout and our plant crossing.

The work will involve installing further crash barriers, an amendment to the pedestrian footpath and safety signage adjacent to the road and at the roundabout. As this will require plant and our workforce to be on the carriageways as well as the crash barriers being partially constructed and therefore not fully functional during the works, we need to introduce the closure for the safety of road users and our workforce.

Throughout these works The Chiltern Brewery will be open as usual, access will be from the Terrick end of Nash Lee Road.

When will these works take place?

The road closure will take place from Monday 21 August to Saturday 26 August.

These dates are subject to change due to circumstances beyond our control. Should we finish the works early, the road closure will be removed.

Duration of works

Works will commence Monday 21 August until Saturday 26 August.

Traffic management will be in place 24 hours a day.

What to expect

Varied activities with both quiet and busier periods.

Road closure on Nash Lee Road with a fully signed posted diversion route in operation.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.

Ensure access to local businesses are maintained.

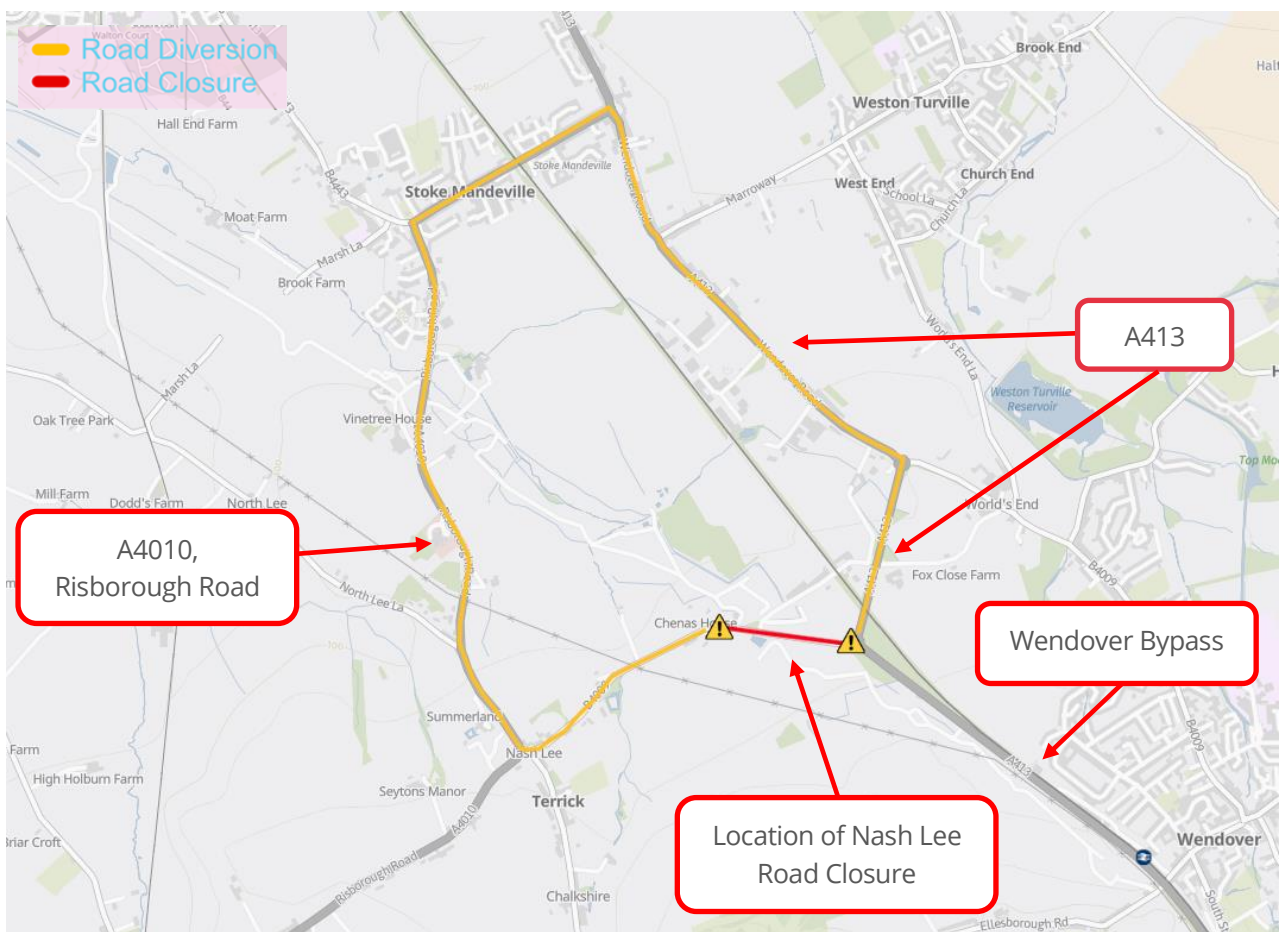
