High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty and its appointed subcontractors are working on behalf of HS2 Ltd to carry out early environmental works between Lichfield and Crewe.

What we are doing

As part of our early environmental works, we are undertaking ecological surveys and roadside hedgerow maintenance around the Mill Lane/ Great Haywood Road junction. These works are required to maintain safe line of sight for road traffic.

Balfour Beatty will be using a tractor and hedgerow flail as well as manual working near any sensitive ecological receptors.

This will form part of regular hedgerow maintenance within the wider area.

We will need to install several variations of temporary four-way and temporary two-way traffic lights at the junction, to manage the safe movement of the vehicles and people needed to carry out the hedgerow maintenance.

When the work take place?

We will put the traffic lights in place from **Thursday 14 September to Friday 29 September 2023 9am-5pm.**

(excluding weekends and Bank Holidays) Daytime working.

What we will do

Install Temporary traffic lights on and on the approach to Mill Lane/ Great Haywood Road junction.

Carry out the work in compliance with the Code of Construction Practice.

Inform you in advance of any changes to the dates and working times shown.

What to expect

The equipment we use may generate some low-level noise, we will be switching off engines when not in use and working during the day to minimise disruption to local residents. We will ensure the traffic lights are only in operation during periods when work is being undertaken to minimise disturbance.

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
