High Speed Two (HS2) is the new high speed railway for Britain. You can sign up for regular updates in your local area at www.hs2inwarwickshire.co.uk.

What are we doing?

In late August we will be carrying out some topographical surveys along Leamington Road, A425. Topographical surveys will help us to finalise the design of the new railway and road alignments and where possible allow us to reinstate features after construction.

To carry out these surveys safely and effectively we will need to put in place traffic lights, so our team can work safely.

When will these works take place?

The short section of the A425 Leamington Road will have traffic management from Tuesday 29 Augus to Thursday 31 August, from 9am to 3pm.

These dates may be subject to change due to circumstances outside of our control, such as weather.

Access will be maintained for residents as well as emergency services within the closure area.


