# Temporary access road maintenance, Bottom House Farm Lane, Chalfont St Giles

High Speed Two (HS2) is the new high speed railway for Britain. This notification is to inform you of maintenance works on our temporary access road on Bottom House Farm Lane, Chalfont St Giles.

## How will this affect you?

Operatives will be visibly working on our temporary access road (TAR) on Bottom House Farm Lane, Chalfont St Giles on:

- 11 September
- From 8am to 5pm

## What will we be doing?

A mobile works unit will be visible on the TAR whilst we carry out maintenance work on gullies and complete the road markings from the A413 to the Chalfont St Giles ventilation shaft. Please see the location map of these works on page 2.

## What about residents and pedestrians?

Residents' access will be maintained at all times as the works will taking place on the opposite side of the lane.

- Remove the traffic management as soon as possible

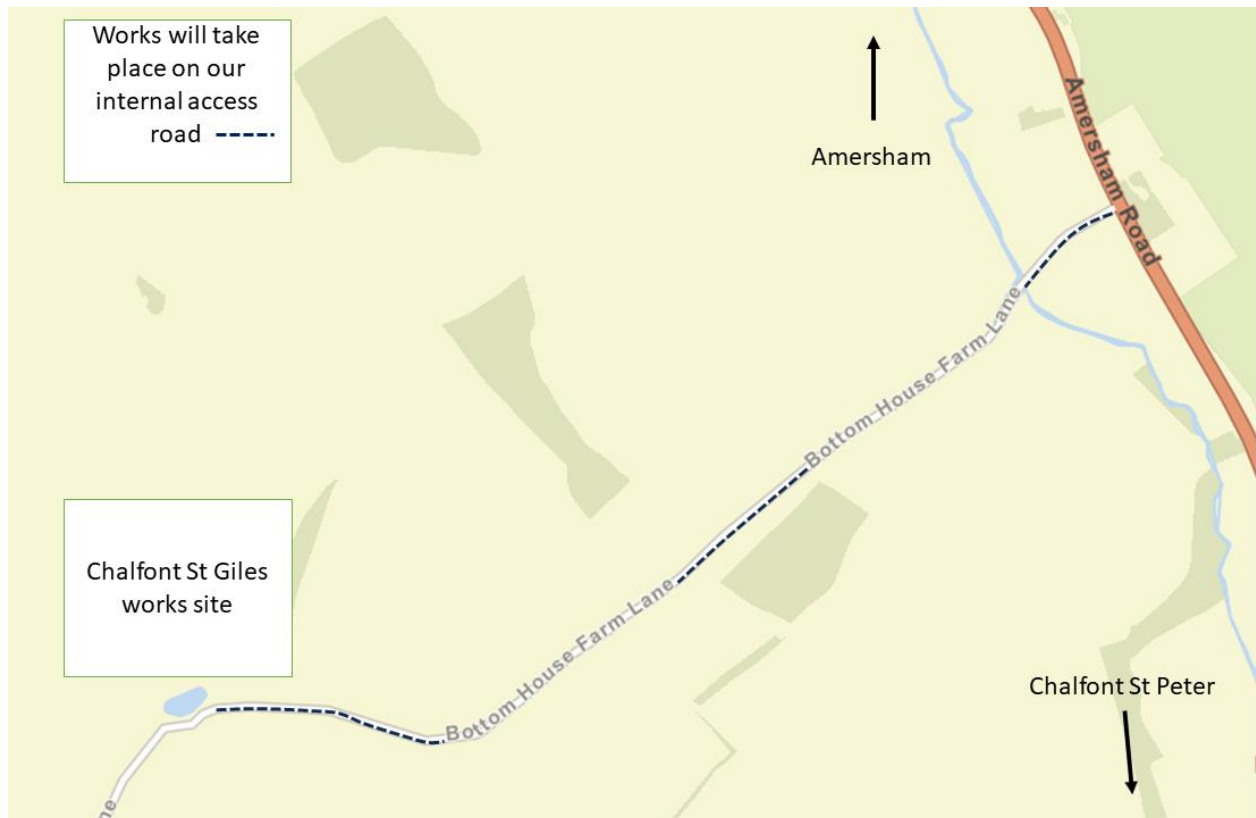
