High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Footpath Closure

We previously notified you that we will be installing a 750-tonne crane at Duddeston Mill Trading Estate. The crane will be used to lift the new freightliner bridge on Duddeston Mill Road into place. The new bridge will be lifted into place over one weekend starting on Friday 8 September 2023.

As we carry out this work, we will need to close the footpath under Duddeston Mill Road rail bridge at 12am on Saturday 9 September until 6am on Monday 11 September. We need to close the footpath to ensure that we keep members of the public safe as the bridge is lifted into place.

The road in this location will also continue to be closed to traffic under Birmingham City Council's current road closure.

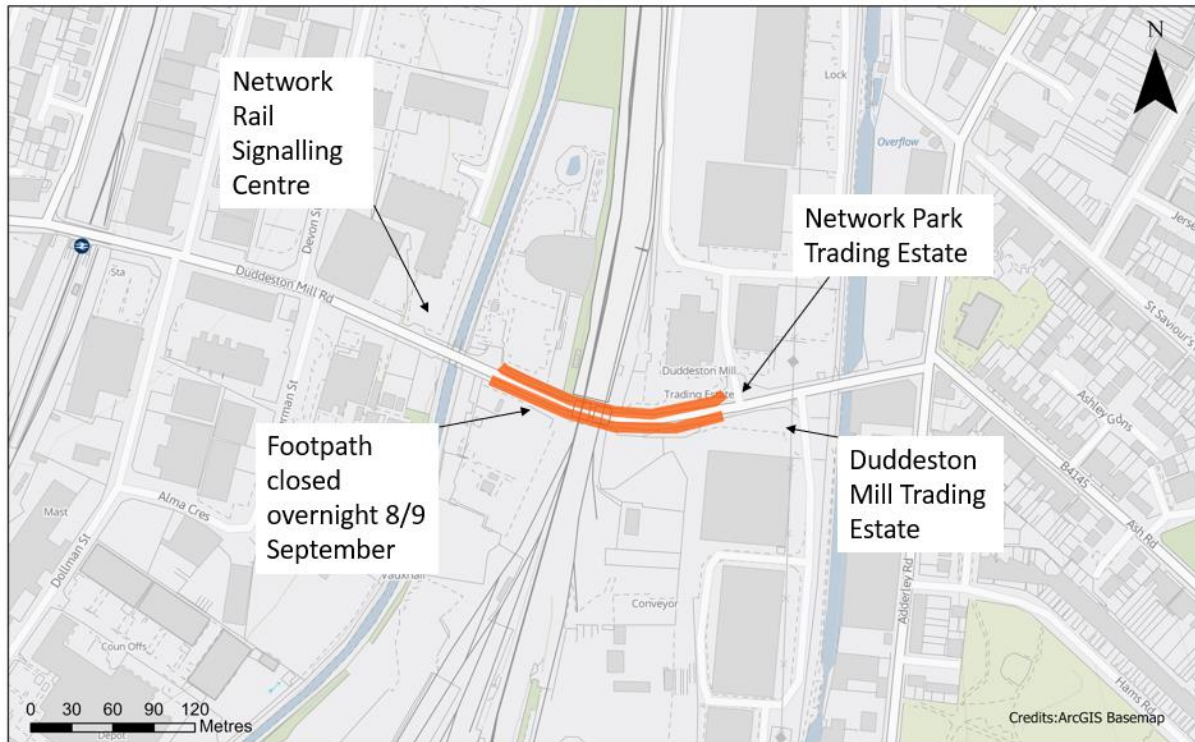
