High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

### Gate Street

We recently wrote to you regarding a temporary one-day closure of Gate Street on Friday 25 August to carry out utility surveys within the road and footpath.

After these surveys are complete, we will then require a series of closures along Gate Street from Monday 4 September until winter 2023. During this time, we will carry out utility diversion works.

Access to businesses will be maintained under marshal control during these works.
