High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

### Footpath Closure

We will be installing scaffolding along a section of Lawley Middleway in order to construct the piers that will hold the HS2 Curzon Viaducts in place in the future.

The scaffolding will be erected on Monday 4 September and deconstructed on Sunday 5 November. On these two days, the team will require a footpath closure to safely work over the footpath. Please see the map on page 2 showing the location of closure and diversion route.

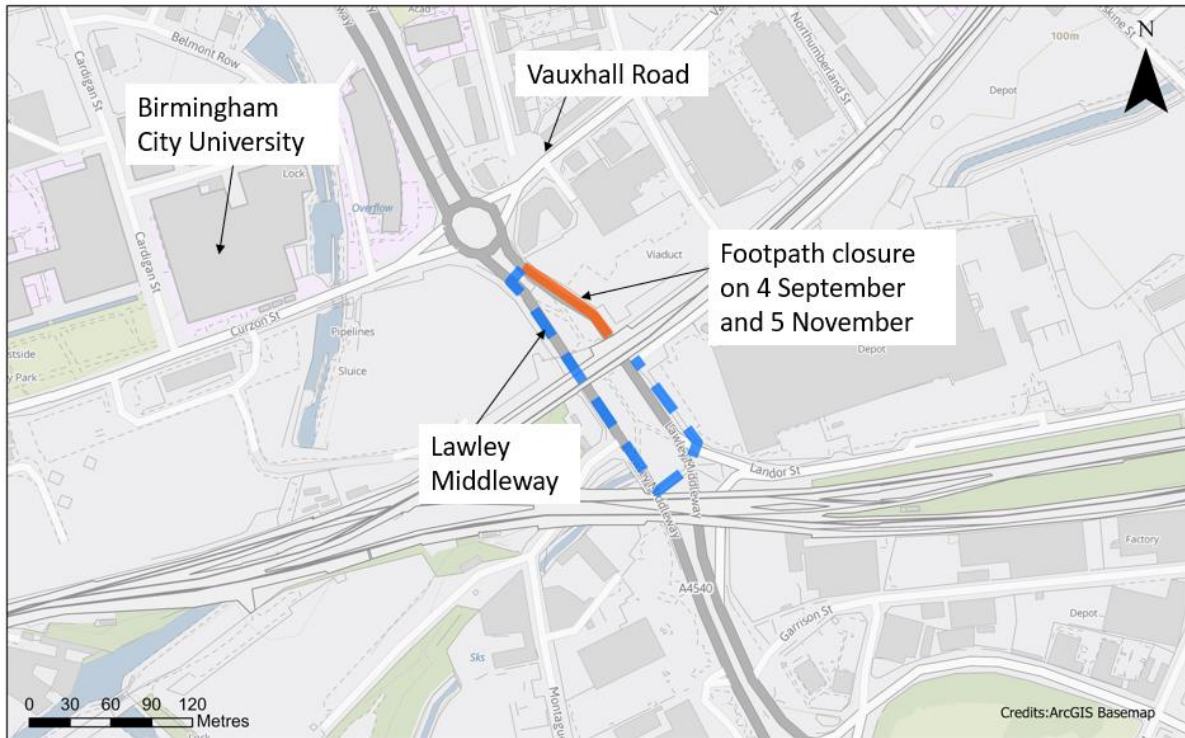
