

Notice of M42 junction 6 to 8 temporary overnight carriageway closures and lane closures - February 2025

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we are doing

The new railway will pass over the M42 on a twin box structure near Birmingham Business Park and the NEC.

This new structure, measuring 300m length by 25m width will cover around 130m of the M42 and will be built in position whilst maintaining three lanes of traffic flowing on the M42.

To prepare for this construction activity we will need to install new safety barriers to protect road users and our workforce. To minimise disruption this work will be done at night and in several phases.

Northbound

- Closed 9pm 3 February until 5am 4 February.
- Closed 9pm 4 February until 5am 5 February.
- Lane 2 and 3 closed 9pm 5 February until 5am 6 February
- Lane 2 and 3 closed 9pm 6 February until 5am 7 February

Southbound

- Closed 9pm 10 February until 5am 11 February.
- Closed 9pm 11 February until 5am 12 February.
- Lane 2 and 3 closed 9pm 12 February until 5am 13 February Lane 2 and 3 closed 9pm 13 February until 5am 14 February (includes full closure of the M6 link northbound with M42 southbound)

A full diversion will be in place using the local road network - **See** overleaf.

Please note that we will reopen the road as soon as it is safe to do so.

Duration of works

Northbound

Closed 9pm 3 February until 5am 4 February.

Closed 9pm 4 February until 5am 5 February.

Lane 2 and 3 closed 9pm 5 February until 5am 6 February.

Lane 2 and 3 closed 9pm 6 February until 5am 7 February.

Southbound

Closed 9pm 10 February until 5am 11 February.

Closed 9pm 11 February until 5am 12 February.

Lane 2 and 3 closed 9pm 12 February until 5am 13 February.

Lane 2 and 3 closed 9pm 13 February until 5am 14 February.

(Includes full closure of the M6 link northbound and M42 southbound)

What to expect

A delay in journey times from between 10-15 minutes depending on direction. Please see the map over leaf.



M42 Northbound diversion 3 and 4 February

The northbound carriageway will be closed from junction 6 to 7a including the link to the M6. **There will be no impact on the M6 Toll.**

Road users planning to travel northbound on the M42 are advised to exit at junction 6, head east along the A45to Stonebridge Island and take the first exit north on the A452/A446. Road users can rejoin the M42 at junction 9.

This diversion route is approximately 8 miles with a journey time of approximately 14 minutes in normal traffic conditions.



M42 Southbound diversion 10 and 11 February

Diversion via A Road – Southbound traffic can exit at Junction 9 and travel southbound on the A446 to M6 Junction 4 Island, take the second exit to continue southbound on the A446 to Stonebridge Island, take the third exit onto the A45 eastbound and re-join the M42 at Junction 6. This Diversion route would offer the most direct routes to visitors to the NEC, Birmingham Airport and Resorts world

Diversion via Motorway – Road users wishing to remain on the motorway network can exit the M42 southbound via M6 southbound link, exit at Junction 3 and take the fourth exit back onto the M6 northbound, down to exit on Junction 4 taking the first exit onto the A446 southbound to Stonebridge Island, take the third exit onto the A45 Eastbound and re-join the M42 at Junction 6.
