What are we doing?

In September 2023 there will be a lane closure on Station Road to complete some core samples of the pavement and undertake compaction tests ahead of the Station Road realignment works starting later this year.

In order to carry out these works safely and effectively, a section of Station Road, will be under 2-way temporary traffic lights.

When will these works take place?

Station Road will be controlled by 2-way temporary traffic lights from Tuesday 5 September to Friday 8 September 2023.

These dates may be subject to change due to circumstances outside of our control, such as weather.

Respond promptly to any complaints and take appropriate action.


