

Notice of piling works within the Westgate site

High Speed Two (HS2) is the new high speed railway for Britain.

From **25 August until 10 October**, we will be carrying out piling works within the Westgate Ventilation Shaft and Headhouse site. The piling is to form a secure foundation for the headhouse which will be built above the ventilation shaft.

How will this affect you?

- We are expecting deliveries of a crane and piling rig on **24 and 25 August 2023** outside of core hours. These deliveries will take place **before 7am, and after 7pm** due to their size, to minimise congestion to the road network. This equipment will be removed from site at the end of the works, also outside core hours.
- For the duration of the works, there will be deliveries of steel piling cages to site outside core hours, up to 3 times per week.
- The parking bay between the Manhattan Business Park gate and West Gate will be suspended during these works. Parking on the footway outside of the business units will also not be possible during these works, as this narrows the access road.



Piling method

We are using an SR-95 Continuous Flight Auger rig. The rig will be used to drill bore holes and pour concrete inside them. Steel Rebar cages will then be installed inside the bore holes to complete each pile.
