High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Saltley Viaduct

We previously informed you that utility diversion works would be taking place along Saltley Viaduct and would require full overnight closures of the road along with a footpath closure.

As these works have progressed, we now need to move the current footpath closure to the opposite side of the road. We plan to make these changes on Tuesday 22 August to allow us to continue to work safely.

Gate Street

On Friday 25 August, we will be carrying out utility surveys within the road and footpath of Gate Street. To allow us to do this safely we will need to close the road for one day between the hours of 6am and 5pm. Access to businesses will be maintained under marshal control during these works.

Adderley Road

On Monday 21 August for approximately five days, we will be reinstating a utility trial hole along Adderley Road. During this time, we will require a short lane closure between Crawford Street and Saltley High Street between 9am and 3pm.

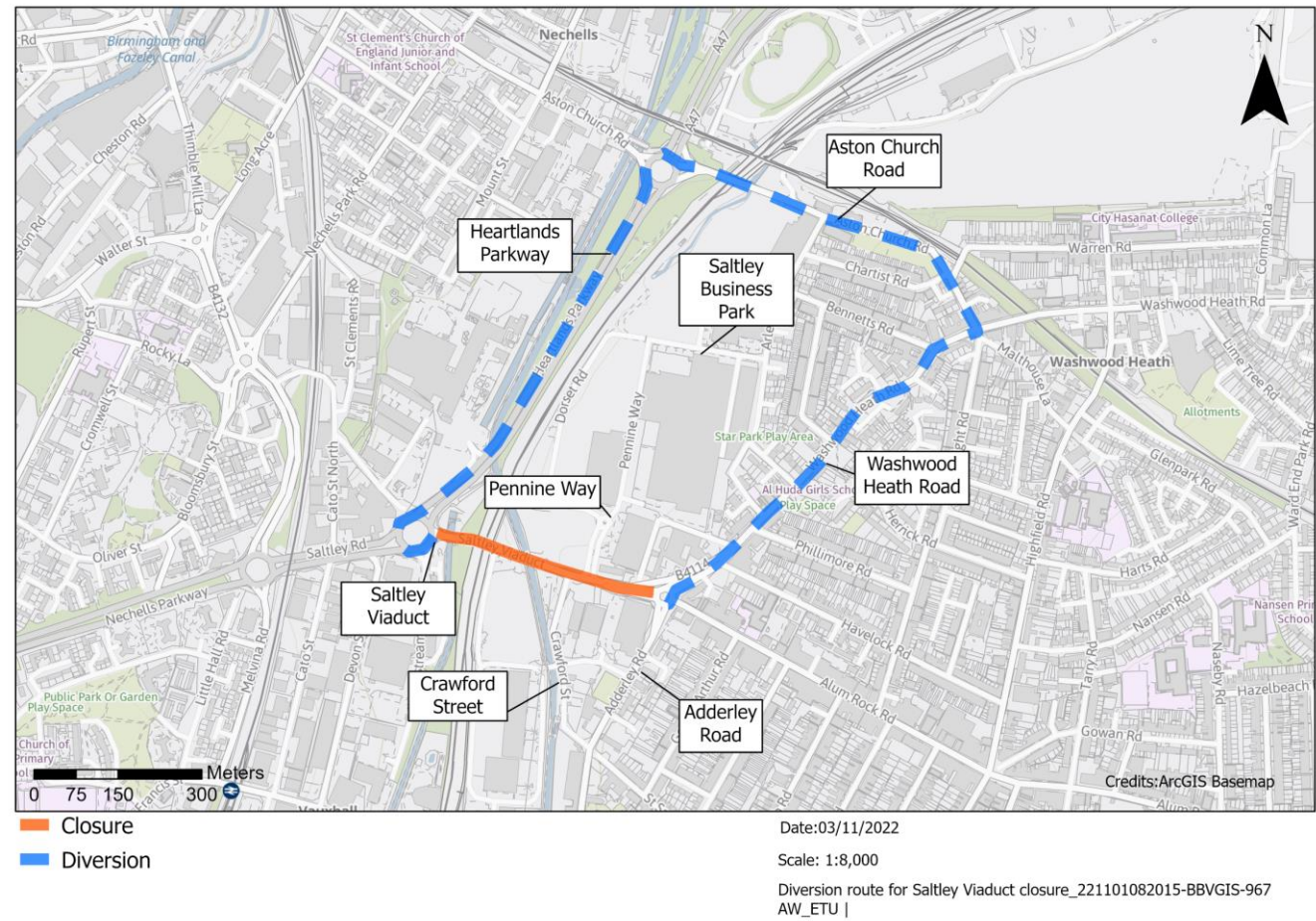
