

# Notice of overnight Thames Water works on Gloucester Avenue and Oval Road

High Speed Two (HS2) is the new high speed railway for Britain.

# **Thames Water update**

We are continuing works to install a protective liner in the sewer on Gloucester Avenue. We now need to install a temporary nonstructural lining.

To do this we will need to access sewer via manholes on Oval Road and Gloucester Avenue. Manhole on **Oval Road** will be used only for emergencies or ventilation purposes. Sewer access will be from new shaft located within Barhale compound on **Gloucester Avenue**.

## **Our work**

From Monday 11 September to Saturday 2 December, between 7pm and 5am, we will access the sewer to install the non-structural liner. Our work will not be noisy.

## **Oval Road**

We will be working in the section of Oval Road, opposite the southern entrance to Gloucester Crescent. Oval Road will be used only in case of emergency or for sewer ventilation purpose.

## **Gloucester Avenue**

We will be working here to access the sewer (Monday to Friday only). A crane will be used only for lifting steel lining into shaft from 7pm to 10pm.
