



# Update of utilities works and site working hours Washwood Heath

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

## Extended working hours

We have previously notified you that we would be working extended hours including weekends at our site off Drews Lane, Washwood Heath. We now plan to also start utilities works in the coming weeks these works will need to also take place during extended hours. This will include working on Sundays starting from Sunday 20 August.

## What to expect

We do not expect the utility works to cause any new impacts to neighbours as we will be working in a section of the site that is away from the residential area.

For this and all other ongoing weekend works we will continue to monitor and control the levels of noise and vibration. We will also keep machine movements to a minimum during the extended period.
