Notice of lane closure on A452 Kenilworth Road – Hampton-in-Arden



High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

The new railway will pass under the A452 Kenilworth Road on a newly realigned section of road that is currently being built alongside the existing dual carriageway. The new section of road will 'tie in' to the existing road at a new roundabout that will be built near Lincoln Farm Truck stop. Before we start to connect the new road with the existing road, we first need to divert all of the utilities that are in the verges and under the carriageway of the old road. This work will ensure that our construction activities do not interrupt the supply to homes and businesses. To do this work safely we will need to close one of the lanes on each side of the dual carriageway from 18 September until 15 December. For safety reasons the lanes will be closed from 8am each Monday and will remain closed all day and all night until 6pm each Friday, although we will only work during our normal working hours which are 8am-6pm.
