High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

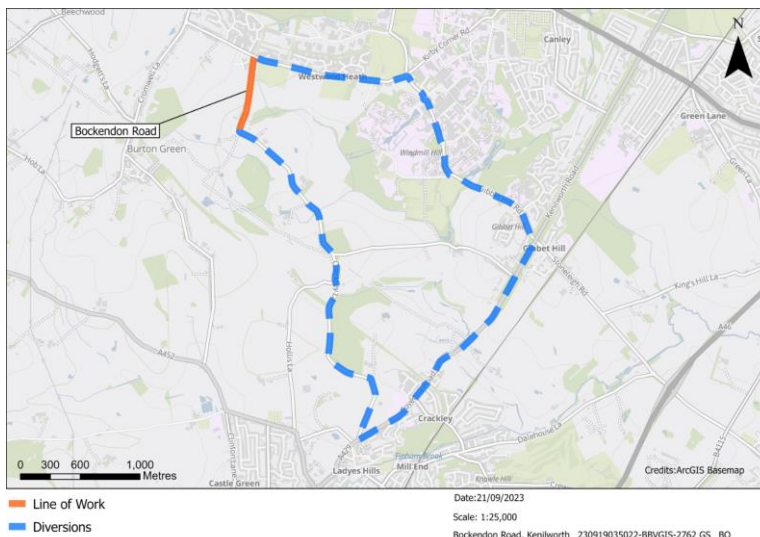
We are required to carry out a series of surveys on Bockendon Road. To safely carry out these surveys, we will need to close Bockendon Road for one day to create a safe working environment.

When will these works be taking place?

Bockendon Road will be closed on Monday 16 October 2023 for one day only between 9.30am and 3.30pm.

A fully signposted diversion will be in place throughout the closure with access to all properties maintained throughout. Bockendon Road will remain open for pedestrians and cyclists.
