



# Notice of temporary overnight closure of A38 northbound carriageway and slip-on at Streethay

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we will be doing


We will be undertaking surveys of the carriageway and cyclical maintenance works on the speed cameras located on the A38 at Streethay. To complete these works safely we will require an overnight closure of the A38 northbound carriageway and the northbound slip-on at Streethay.

## When the work will take place

We will install a temporary overnight closure on the A38 northbound carriageway and slip-on from 11 October to 12 October between 9pm to 5am. A fully signed diversion will be in place during this time.

## Where we will be working

The map below details the closure and the signed diversion route.

Temporary overnight closure of A38 northbound on 11 October to 12 October 2023 between 9pm to 5am.
