#### What are we doing?

At the end of September 2023, we will be carrying out some works to complete the connection for the temporary gas main diversion on Gawcott Road. These works are planned to be completed under 3-way lights.

To carry out these works safely and effectively, a section of Gawcott Road/Perry Hill will require traffic management.

These works are an important step towards the re-alignment of Gawcott Road/Perry Hill over the new bridge, currently under construction.

#### When will these works take place?

A section of Gawcott Road/Perry Hill will be under traffic management from Monday 25 September until Friday 6 October 2023 near the entrance of the Great Moor Sailing Club.

These dates may be subject to change due to circumstances outside of our control, such as weather.

Respond promptly to any complaints and take appropriate action.


