High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing.

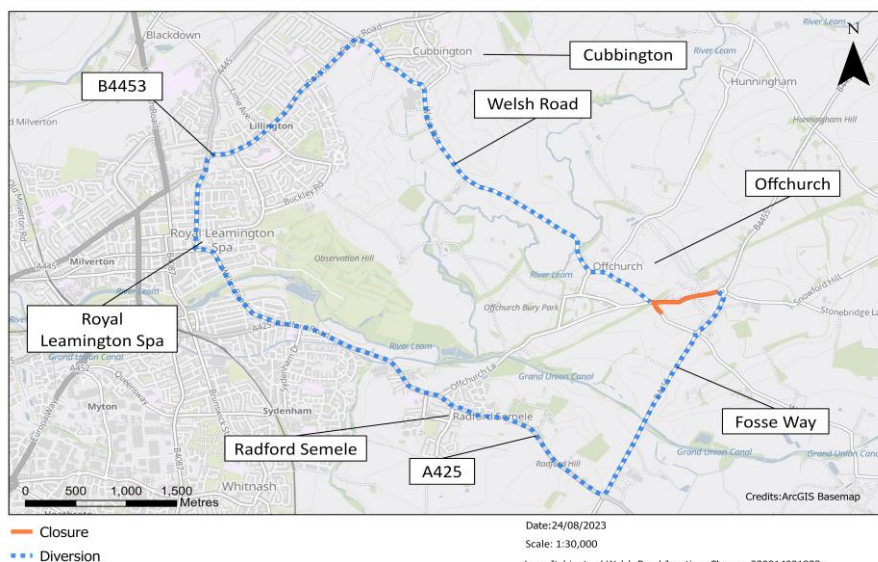
To support the project design, we need to carry out ground investigation works along Long Itchington Road and Welsh Road.

To carry out the works safely we will close Long Itchington Road at the junction with Welsh Road in Offchurch.

When will the works take place?

The works will start on 25 September through to 13 October, with the closure in place 24 hours a day. Access will be maintained for residents, pedestrians, and cyclists throughout the closure.

There will be no through route from Offchurch to Fosse Way. Access to Offchurch Greenway car park will only be possible from the Fosse Way.
