High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Saltley Viaduct

From Monday 25 September, for approximately three weeks we will be carrying out utility works along a section of the footpath on Saltley Viaduct.

To complete these works, we will put in place a set of two-way temporary traffic signals along Saltey Viaduct, from 9.30am until 3.30pm from Monday to Friday. These signals will be in place to maintain a safe crossing point for pedestrians in the area.

During this time, we will also close a section of the footpath (shown on the map below). The footpath will be closed to maintain a safe space between the public and the works area. The footpath closure will be in place until the works are complete and then will re-open to the public.

Access to the bus stops will be maintained during these works.

Pennine Way

From Monday 25 September, for approximately three weeks between 9:30am and 3:30pm Monday to Friday, there will be no right turn from Pennine Way onto Saltley Viaduct. This is to maintain a safe space between the public and the works area.

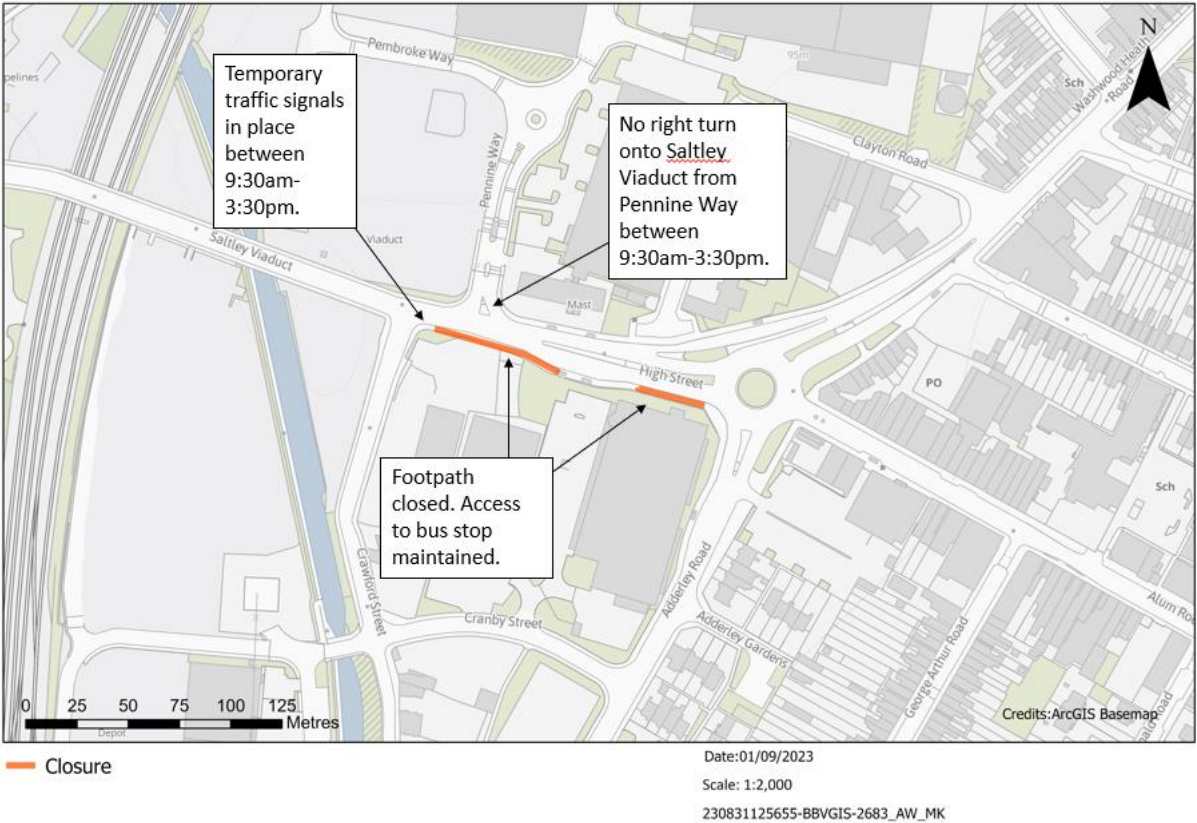
