HS2 Update

Northolt Tunnel East | November 2023

High Speed Two (HS2) is the new high speed railway for Britain. Phase One of HS2 - from London to the West Midlands - is now well into its main construction stage, including tunnels and ventilation shafts between Euston and Hillingdon, and a new station at Old Oak Common

Tunnel Boring Machines to Launch

In early 2024, we will launch a tunnel boring machine (TBM) to build the Northolt Tunnel East between Old Oak Common and Greenpark Way, near Greenford station. We expect the TBM to take approximately twelve months to reach its destination at the Greenpark Vent Shaft in Greenford. Once complete, the tunnel will be around 5.5km (3.4 miles) long and between 12 metres to 40 metres in depth.

The Old Oak Common (OOC) Tunnel is a 360 section of the NTE constructed using a different method between VRCB and Old Oak Common Station.

Tunnel Boring Machines have been named

The next two TBMs have been named in preparation for them being launched early next year. We asked the local community to choose two inspirational women with a connection to Ealing from a shortlist of five. TBM naming helps communities remember and celebrate great local woman from all walks of life.

After receiving over 500 votes from the local community, two names were successfully selected. These names are Emily Sophia Taylor and Lady Anne Byron. The two names will be printed and placed on the side of each TBM.

Who are they and what did they do?

- Lady Anne Byron lived in Ealing during the first half of the 19th century. She established the Ealing Grove School in 1834 – a school for the working classes - in an era when education was mainly for the wealthy.
- Emily Sophia Taylor was Ealing's first female mayor, she was an active member of the Education Committee and the Child Welfare Committee.

Lift Off!



In October 2023, the next big stage of the NTE programme began. As part of the preparation works, we started to lift and lower parts of the TBMs into the shaft at VRCB which is over 25 metres deep.

The pieces being loaded are incredibly large and heavy; the front shield alone weighs 315 tonnes, is 9.1 metres in diameter and 5 metres long. The lift of these large loads are being successfully completed due to months of hard work and planning from many different teams at HS2.
