

# Notice of traffic management on A452/A446 - Marston Green

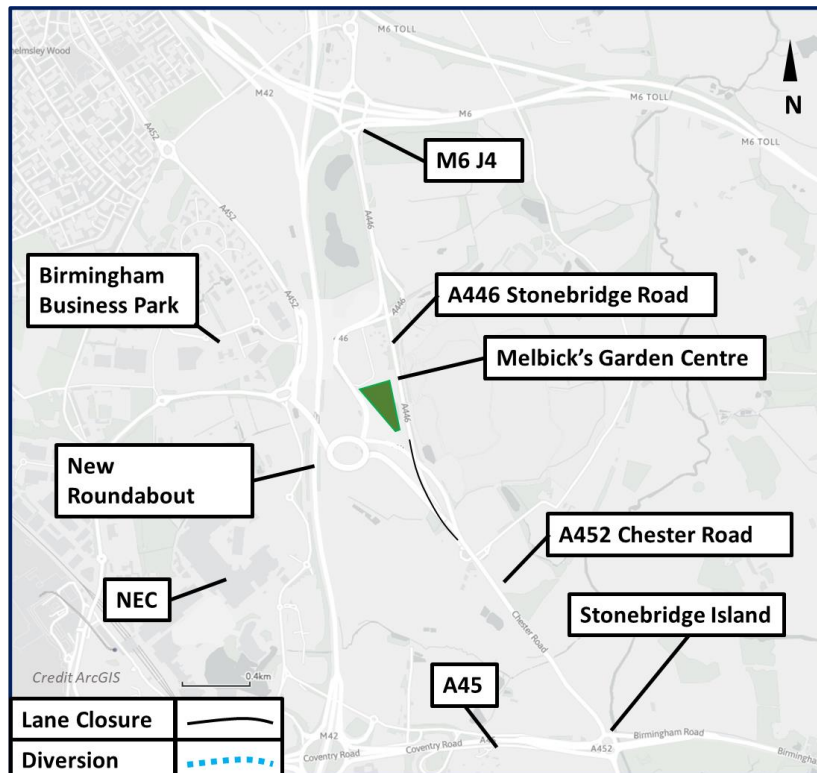
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we are doing.

To ensure the local road network is fit for purpose when the future HS2 interchange station is operational, we have been improving and expanding the existing road network. Located near to the NEC and Birmingham Airport, the Interchange Station will be a major transport gateway for the region. A new roundabout has been constructed linking the Interchange station to the A452 and the A446 trunk roads. As our work on this junction nears completion, we will need to demolish a disused bridge structure over the A446. Before doing so, we will need to undertake a series of surveys on the structure so that the demolition can be carried out safely and efficiently.

In order for us to carry out these surveys we will need to close a lane on the northbound carriageway between 9pm and 6am on 30 October, 31 October and 1 November.
