



# Notice of traffic management A452 – Stonebridge Island

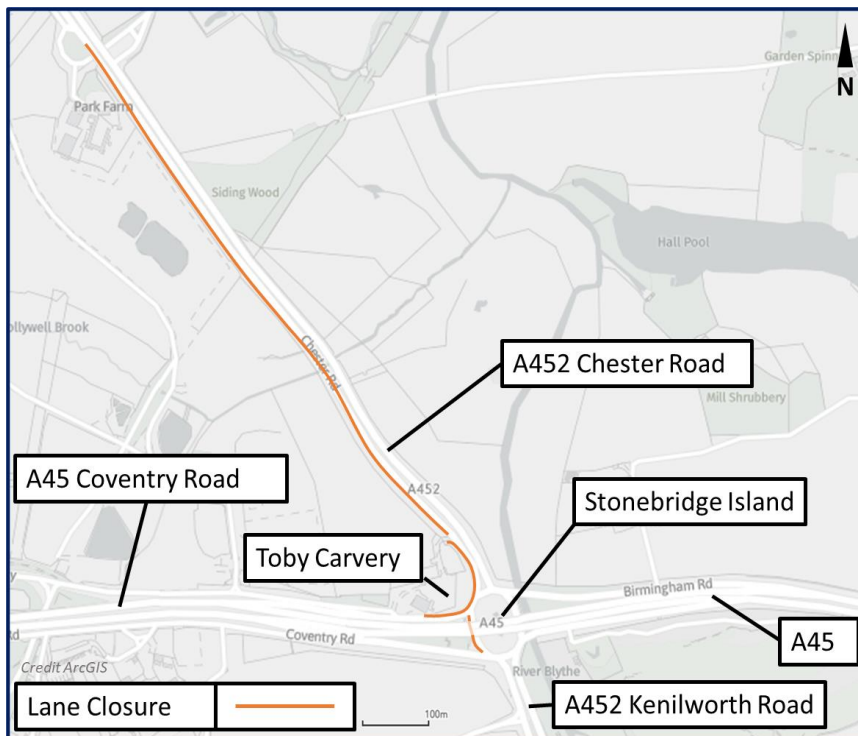

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

## The work we will be doing

The new railway will pass under the A45 as it approaches the new interchange station. This requires significant work to the road network in this area. Before these works can take place, a number of utilities need to be moved and diverted to make sure that our works do not have an impact on the supply. On 23 and 24 of November, we will be digging trial holes in the verge of the A452 so that we can better understand the ground conditions before diverting a water main. To do this safely we will need to close a lane on the A452 and on part of the Stonebridge Island between 9:30am and 3:30pm on 23 and 24 November.
