High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

### A47 - Heartlands Parkway/Saltley Viaduct - lane closures

We will be carrying out a series of utility works on A47 Heartlands Parkway between Saltley Viaduct and Cuckoo Road from Sunday 5 November until the end of February 2024 (approximately 16 weeks). During this time, we will require a series of localised lane closures on either side of A47 Heartlands Parkway. These lane closures will be in place between 8am and 6pm on A47 Heartlands Parkway and 24 hours on Aston Church roundabout out of City).

The dates of our works are subject to change depending on ground and weather conditions. Access to all businesses and frontages will remain open as usual.

Ensure that our work areas are safe and secure.

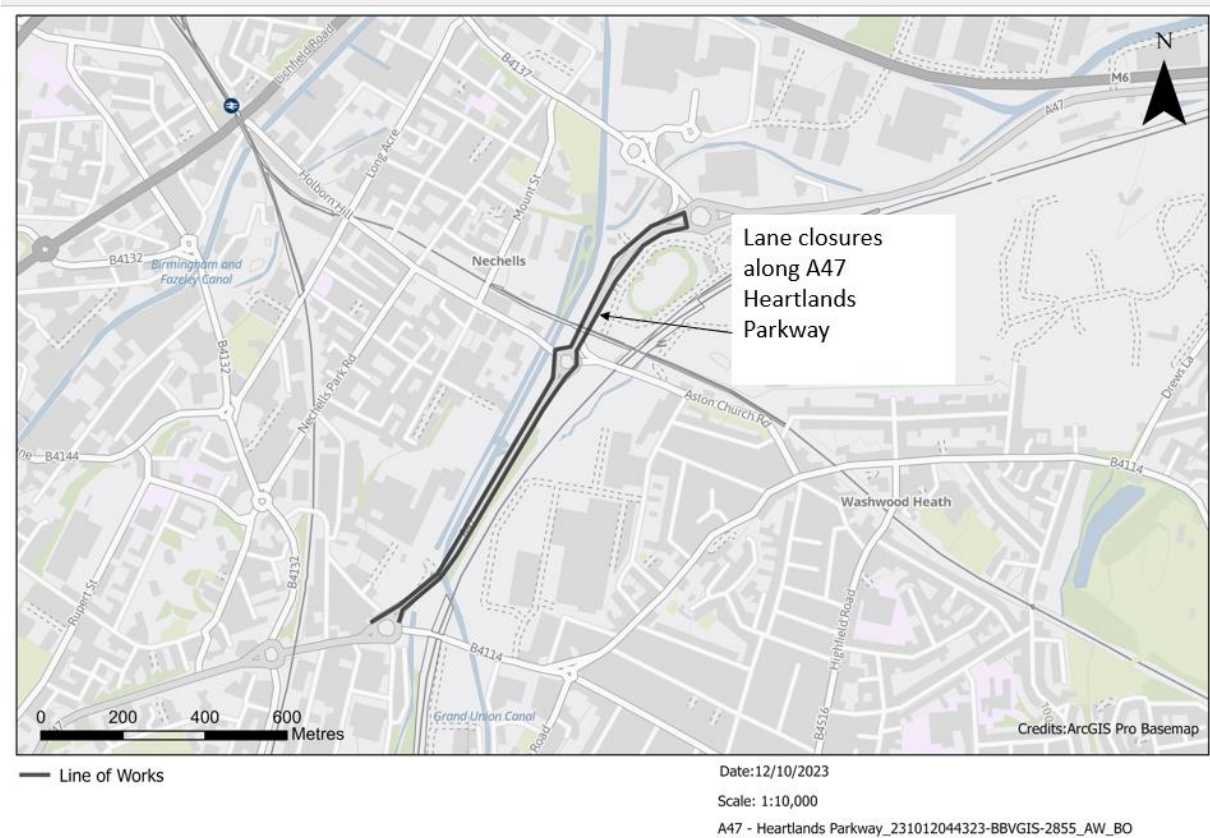
